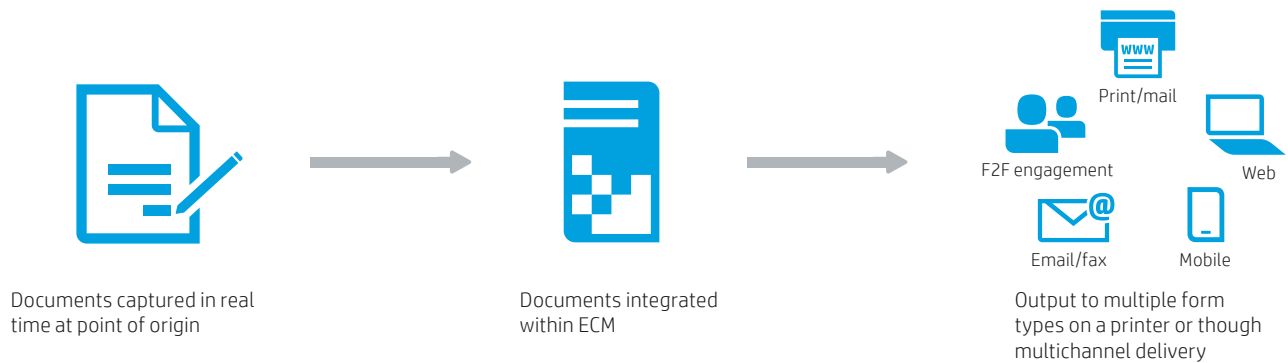
HP solution at a glance
