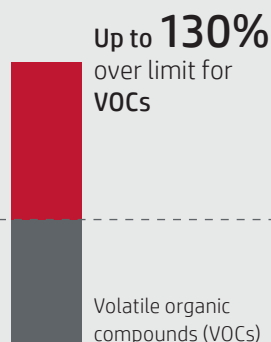
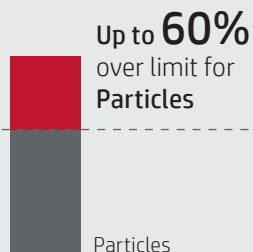
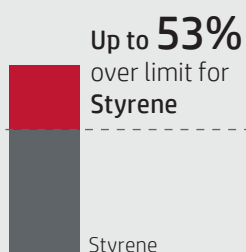
HP invests in the indoor air quality performance of HP printing systems

Know the risks to air quality when using clone cartridges

Replacing the Original HP toner cartridge with a clone cartridge causes the HP printing system to fail indoor air emission standards. Clone cartridges fail EPEAT emission standards during testing, with values over the allowed limits.² If you use EPEAT as a purchase requirement, your printer may no longer qualify when using non-HP cartridges.
