## Service overview

Deploy Chrome™ devices of any size with almost zero IT labour requirements. Chrome Device Management Enrollment Service is a factory service for Chromebooks™ and Chromeboxes™ that enrolls your devices into your Chrome Device Management account at the factory. This way, they arrive at your door ready to go.

Reduces work for IT staff	All devices and user policies are pre-configured prior to delivery so your IT team doesn't have to worry about tedious manual unpacking and enrollment of each device prior to deployment. End users can simply log-in to their own account and get to work. Plus, devices can be shipped directly to end users without ever being touched by onsite IT.
Increased security and productivity	Devices arrive enrolled into your domain and are managed from the start, preventing them from being used without policy management and eliminating the need to wipe and re-enroll devices due to user error during enrollment.
Improved end user experience	Provides a consistent end user boot experience with ready-to-go devices. Users simply log-in to their Google account, and all necessary apps and settings are available.



## Delivery specifications

- All Chrome devices that are managed with Chrome Management Console must be enrolled into the console.
- Enrollment is a manual process requiring the Chrome device to be unboxed, booted up, and connected to the internet. A special log-in process is used to complete enrollment.
- All of the steps of Chrome Device Enrollment Service will be completed in the factory before the device is shipped directly to the customer. These steps include updating Chrome OS™ on the device if needed, enrolling the device in your domain, and validating policies.
- Devices can be shipped directly to the end user without assistance from your IT team.
- Devices are shipped configured with the following:
  - Latest channel-stable OS version
  - Preconfigured Wi-Fi networks
  - Remotely managed IT policies
  - Required applications
  - Recommended bookmarks
  - Preset homepage

## Customer responsibilities
