

## **Nomination Process**

- The Design Competition (**‘Competition’**) shall run on [www.hp.com/in/en/Skyline2050](http://www.hp.com/in/en/Skyline2050) from the date it shows live on the portal. HP shall limit or extend the Contest Period in its sole discretion and as it deems necessary.
- The Competition is open to all Architects (Registered with Council of Architecture, India) & qualified structural engineers based in India. All Participants must ensure that his/her participation in the Competition is lawful and is in accordance with the applicable laws. Entry to the Competition must be completed on or before the closing hours of 4<sup>th</sup> May, 2018 (i.e. 00:00 hours) by submitting a fully filled up registration form & their design submissions.

## **Terms and Conditions for submission of entry forms & designs:**

- The duly filled in online registration form must be submitted with all mandatory information required, as indicated.
- The registration form should be submitted along with the design as per the defined file size & format prescribed on our online webpage. Only one participant per design is eligible to qualify for the contest.
- No participation or other fee is required to be paid for participating in the Competition.
- The Participant agrees to provide HP current, complete and accurate information. HP reserves the right to verify the information provided in each submission, if required.
- HP & HP authorized representatives reserve the right to use the data for communication purposes including but not limiting to sending mail and making phone calls.
- A one-page profile of the architect specifying milestone projects, (successfully completed); Awards/recognition received and passport size photograph shall be submitted to HP along with the registration form and designs.
- Submissions received by HP shall be the original works of art created by the respective participant making the submission.
- The participant(s) including the winners, grant HP a worldwide, exclusive & unlimited license to use/ utilize their artwork/design in the manner it deems fit including for HP’s promotional and/or marketing purposes, with or without modifications.
- HP or its Affiliates shall be entitled to use, in any manner, the name, photographs and other details of the selected Participant(s) or any likeness and status in any publication including the Prizes awarded to them. By participating in the Competition, all Participants hereby agree to the same. HP may, at its discretion, choose not to disclose the identity of the selected Participant to other Participants.
- Submission of the registration form indicates the Participant’s acceptance to these terms and conditions. Any breach or default by a Participant of any of the Terms and Conditions herein shall result in immediate disqualification without notice.
- Entries received will be evaluated by a jury of judges, HP will decide and select the jury. - Representatives from the winning entries should be present in the awards night.
- Hardcopy of the complete design envisioning the city skyline should be submitted in A1 or A2 size in pdf format with file size of upto 100 MB to HP. The details of where it should be sent to will be intimated by email.
- A one-page profile of the architect specifying milestone projects, (successfully completed); Awards/recognition received and passport size photograph shall be submitted to HP along with the registration form and designs.

- Nomination form along with the supporting documents submitted in any other size/format other than specified above shall be rejected.
- Nominations which fail to comply with the other above guidelines, will be rejected. Any decision taken by HP for rejecting any entry /submission shall be final and binding and not subject to any dispute or challenge.
